Junior High Ski Day at Whispering Pines Ski Area

We are excited to offer all our Grade 7-9 students a Ski Day on **March 11!!** Our students will be bussed to Whispering Pines early on March 11 (arrive at Bezanson School by 7:10am to leave the school at 7:30am sharp), and will return to Bezanson around 6:30-7:00pm. ***Parents will be asked to drop their child(ren) off at the school by 7:10am, and pick them up upon their return (students will call from the busses to let their parents know the pick up time).***

You will find attached the following forms to be filled out for your child:

- 1) Bus Permission Form (p. -2-) - required for ALL students
- 2) Snowboarding/Skiing Registration (p. -3-) - required for ALL students for Snowboarding/Skiing.
- 3) Snowboard/Ski Rental Form (p. -4-) - required for any students who will be renting equipment.

The kitchen will be open at the ski hill. Students are welcome to buy lunch there, or bring a bag lunch. Personal items cannot be brought into or stored in the chalet so please do not bring more than you absolutely need! Outside lunches cannot be brought into the chalet, and they ask that all those using the chalet be considerate of others who may be waiting to come in to eat as they need to limit the numbers permitted in at a time.

If you have more than one child, you are welcome to pay with one cheque, but please attach all the forms to the payment. All cheques must be payable to Bezanson School.

We hope all our Grade 7-9 students will be able to join us for this fun day! If the cost makes this program prohibitive for your family, please contact the school as we will do everything we can to have all our students join us for the day.

*For those students that own skis/snowboards, we ask parents to please **clearly label** their child's gear and have it at the school by 7:10am March 11 to be loaded into a staff member's truck for delivery to the ski hill.*

EQUIPMENT RENTAL & LIABILITY RELEASE AGREEMENT

I accept for use AS IS the equipment listed on this form, and accept full financial responsibility for the care of the equipment while it is in my possession. I will be responsible for the replacement at full value of any equipment rented under this form, but not returned to the rental facility. I agree to return all rental equipment by the agreed date.

I understand that the binding system cannot guarantee the user's safety. In downhill skiing and snowboarding with skiboards equipped with release bindings, the binding system will not release at all times or under all circumstances where release may prevent injury or death, nor is it possible to predict every situation in which it will release. In snowboarding, cross-country skiing, snowboarding with skiboards equipped with non-release bindings, snowshoeing and other sports utilizing equipment with non-release bindings, the binding system will not ordinarily release during use; these bindings are not designed to release as a result of forces generated during ordinary operation.

I understand that the sports of skiing, snowboarding, skiboarding, snowshoeing and other sports (collectively "RECREATIONAL SNOW SPORTS") involve inherent and other risks of INJURY and DEATH. I voluntarily agree to expressly assume all risks of injury or death that may result from these RECREATIONAL SNOW SPORTS, or which relate in any way to the use of this equipment. I understand that a helmet designed for RECREATIONAL SNOW SPORTS use will help reduce the risk of some types of injuries to the user at slower speeds. I recognize that serious injury or death can result from both low and high energy impacts, even when a helmet is worn.

I AGREE TO RELEASE AND HOLD HARMLESS the equipment rental facility, its employees, owners, affiliates, agents, officers, directors, and the equipment manufacturers and distributors and their successors in interest (collectively "PROVIDERS"), from all liability for injury, death, property loss and damage which results from the equipment user's participation in the RECREATIONAL SNOW SPORTS for which the equipment is provided, or which is related in any way to the use of this equipment, including all liability which results from the NEGLIGENCE of PROVIDERS, or any other person or cause.

I further agree to defend and indemnify PROVIDERS for any loss or damage, including any that results from claims or lawsuits for personal injury, death, and property loss and damage related in any way to the use of this equipment.

This agreement is governed by the applicable law of this state or province. If any provision of this agreement is determined to be unenforceable, all other provisions shall be given full force and effect.
